
The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

Item 1 - In lieu of rates shown for packing & unpacking in Tristate 50-T, Item 301, and Tristate 51-W, Item 110, hourly rates shown on Page 94-B shall apply for packing and unpacking labor at all points in Pennsylvania. In lieu of rates shown for containers in Tristate 50-T, Item 310, and Tristate 51-W, Item 115, the following rates will apply at all points in Pennsylvania for carrier supplied containers :

NOTE A - When mover supplies packing materials to shipper, a minimum charge of **\$75.00** will apply.

NOTE B - When the carrier does not have mattress bags available for any size mattress on the chart above, shrink-wrap will be used as an alternative. Charge whenever shrink-wrap is used for mattresses or other furniture items will be **\$20.00** per roll (charged per quarter roll).

NOTE C - Packing Materials (i.e. newsprint, paper pads, and tape) are factored into cost of container.

NOTE D - If custom container is required, where two cartons are joined together, the cost will be the full amount of the higher cost carton and one-half of the lower cost carton.
