Dear Secretary Chiavetta:

This firm represents Marathon Power, LLC (“Marathon”). Please accept this request for Marathon to maintain its current financial security reduction of 5% of its most recent 4 quarters of gross receipts, in accordance with the Commission Order deemed final on October 16, 2018, at Docket No. P-2017-2608078. Marathon’s Financial Security Reduction Petition was granted on June 29, 2022, and expires on December 31, 2022.

This filing includes the following required documentation:

- Marathon’s most recent four quarters of gross receipts, including the 5% gross receipt calculation;
- Recent REV-423 Specialty Tax Estimated Payment Form from PA Department of Revenue stating the total amount of gross receipts taxes that Marathon pre-paid towards the current calendar year;
- E-Mails regarding Alternative Energy Portfolio Standard obligations. Marathon currently owes a Tier 2 Alternative Compliance Payment and is awaiting an invoice from the PUC which has been delayed due to the Director who signs the invoice being out of the office. Marathon will promptly pay the Tier 2 ACP when the invoice is received and will update this filing with the PUC to confirm payment;
- Proof of compliance with the Commission’s required annual fees and supplemental annual fees;
- Proof of financial security compliance. A copy of the bond was not available at the time of filing, but will be provided upon receipt and the original will be sent to the PUC;

- Certificate of Service to all five statutory agencies and all electric distribution companies where Marathon is licensed to operate; and
- Marathon's Contact Information.

Marathon is unable to provide a Department of Revenue Tax Status Letter of Good Standing at this time due to an outstanding balance in the amount of \$550.00. \$500.00 of the balance was paid today and the remaining \$50.00 cannot be paid until Monday since only one payment is allowed per business day. Marathon will provide a Tax Status Letter to the PA PUC immediately upon receipt when the payment issue is resolved. Proof of today's \$500.00 payment is attached.

It will be a while until your request can be completed.

To explain; today is the last day of the 2021-2022 reporting year ‘true-up’ period for EGSs and EDCs to meet their AEPS obligations by retiring the required number of alternative energy credits (AECs). Once the true-up ends the AEPS program administrator will review the retirements for all 128 entities with obligations, to verify compliance. The administrator will then provide to EGSs, who met their obligations, an email confirming that obligations were met. The administrator will also provide commission staff a list of entities that did not retire sufficient AECs to meet their obligations. Staff from the Commission’s Bureau of Technical Utility Services will issue a letter of Non-Compliance to entities who did not meet their obligations. The Non-Compliance letters allow entities to come into compliance by paying an alternative compliance payment.

If Marathon retired sufficient credits to meet their Alternative Energy Portfolio Standards obligations, documentation will be sent within two weeks. If Marathon did not retire enough

credits, documentation will be delayed until an alternative compliance payment is made.
