On September 22, 2021, Connect Holding LLC (“Connect Holding”); Lumen Technologies, Inc. (“Lumen”); and Lumen’s operating subsidiaries, the United Telephone Company of Pennsylvania LLC (“United Telephone”) and CenturyTel Broadband Services, LLC (“CTBS”) (collectively, “Joint Applicants”) filed a Joint Application in the above-captioned matter seeking approval from the Pennsylvania Public Utility Commission (the “Commission”) to complete the proposed transfer of control of United Telephone and CTBS (the “Acquired Companies”) from Lumen to Connect Holding (the “Transaction”). On April 25, 2022, the Commission approved the Transaction and directed Joint Applicants to notify the Commission within 30 days of the date of the consummation of the Transaction.
