NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in half-hour periods; fractions of one-half hour considered as one-half hour. NOTE 4 - Minimum Transportation Charge: Sundays and Holidays (any hour): 4 hours at rates named in Columns 1 and 2. Saturdays (any hour) or Weekdays (5:01PM to 7:59AM): 4 hours at rates named in Columns 1 and 4. Weekdays (8:00AM to 5:00PM): 4 hours at rates named in Columns 1 and 3.

NOTE 5 - Carrier will supply and charge for supervisor or supervisors as requested by shipper.
