Dear Secretary Chiavetta:

On October 5, 2022, the Pennsylvania Office of Consumer Advocate formally requested, via letter, that the Public Utility Commission issue an extension of the deadline for reply comments at the above-referenced docket regarding the Notice of Proposed Rulemaking Order. Comments are currently due on November 15, 2022 and reply comments are due on December 30, 2022. The Order allowed 45 days for comments and 45 additional days thereafter for reply comments following the Order's publication in the *Pennsylvania Bulletin*, which occurred on October 1, 2022.

By this letter and pursuant to Section 1.15 of Chapter 52 of the Pennsylvania Code (52 Pa. Code §1.15), the Energy Association of Pennsylvania ("Association") for itself and its members supports the request for an extension of time until Tuesday, January 17, 2023 for the filing of reply comments to the Notice of Proposed Rulemaking Order at the above-captioned docket.

Given the complexity of the issues addressed in the Order and the intervening holidays, the Association agrees with OCA that the current reply comment due date would provide too brief a period to adequately review all the filed comments and then prepare appropriate responses. Therefore, the Association supports application of any extension granted to all parties filing in this docket.


