Transport requests are received by phone, fax or secured website portal provided by brokers. Vehicles are dispatched through advanced scheduling utilizing CTS Tripmaster software. Communication with drivers is done through a dashmounted cell phone private walkie-talkie app.

Approximate 10-20 drivers based on demand. All drivers undergo a strict vetting process that includes pre-employment and annual background, sex offender and motor vehicle record checks that are done through PennDot and Verifirst, a third party background company.

Driver training includes but is not limited to basic first aid, cpr, bloodborne pathogens, passenger assistance, wheelchair securement, defensive driving and given a road test.

Drivers are drug tested at hire, annually and upon reasonable suspicion. Solvere Transport, LLC has a zero tolerance drug and alcohol policy.
