Data Request

1. Please provide evidence of Mr. John Tassi, II's qualifying experience as required by 52 Pa. Code §3.381(c)(1)(iii)(A)(II)(-I-). Copies of W-2s which clearly demonstrate in excess of 2 years of employment with Lee's Moving & Storage are acceptable; however, a signed letter from the previous company's ownership or management would be preferable. The letter should clearly indicate positions held and periods of employment.
2. What steps has the applicant taken to ensure that the requirements of 52 Pa. Code §3.381(c)(1)(iii)(A)(II)(-I-) will be **continuously** met throughout at least the initial two year period of Mr. Carroll's ownership? Has at least a two year employment contract been completed with Mr. Tassi, and what are the applicant's contingency plan should Mr. Tassi leave the applicant's employment prior to the first two years of the applicant's operations?
