Please accept this Annual Compliance Filing on behalf of Inspire Energy Holdings, LLC ("Inspire Energy") requesting that Inspire Energy's required level of financial security continue to be reduced to the level of 5% of its last twelve months of gross receipts. Inspire Energy's initial security reduction request was granted via Secretarial Letter on July 19, 2021, and its continued security reduction request was approved on November 10, 2021. Inspire Energy's current financial security instrument expires on January 10, 2023. Please find the following information and documentation in support of Inspire Energy's Annual Compliance Filing:

- 1) Inspire Energy's gross receipts in Pennsylvania for the most recent twelve months (October 2021 through September 2022) attached hereto as Appendix A (CONFIDENTIAL);
- 2) Inspire Energy is current with its tax liabilities to the Commonwealth of Pennsylvania and is providing proof of its prepaid gross receipts taxes toward its estimated revenues for the current year in Appendix B (CONFIDENTIAL);
- 3) A letter evidencing Inspire Energy's compliance with Alternative Energy Portfolio Standards requirements is attached hereto as Appendix C (CONFIDENTIAL); and
- 4) Inspire Energy is compliant with the Commission's annual and supplemental fee requirements.

Inspire Energy has requested a Tax Status Letter from the Pennsylvania Department of Revenue to evidence that it is current with its tax liabilities to the Commonwealth. Inspire Energy will supplement this filing upon receipt of the Tax Status Letter.

To satisfy the financial security requirements, Inspire Energy will submit an original financial security instrument to the Commission.
