The purpose of this Letter is to advise you that your Application, at Docket No. A-2022-3035241, has been **DENIED** by the Pennsylvania Public Utility Commission (Commission). The Commission has determined that a Certificate of Public Convenience **WILL NOT BE GRANTED** for the following reason(s):

- 1) **QUESTION #3 OF THE DATA REQUEST LETTER REGARDING WHAT TYPE OF COMMODITIES THE APPLICANT INTENDS TO TRANSPORT WAS NOT ANSWERED IN ITS ENTIRETY.**
- 2) **QUESTION #4 OF THE DATA REQUEST LETTER REGARDING A HOUSEHOLD GOODS IN USE MOVE AND A PROPERTY MOVE WAS NOT EXPLAINED OR ANSWERED IN ITS ENTIRETY.**
- 3) **APPLICANT WAS INSTRUCTED TO FILE AN APPLICATION FOR MOTOR COMMON CARRIER OF HOUSEHOLD GOODS IN USE SINCE IT STATED IN QUESTION #10 OF ITS APPLICATION THAT THE TYPE OF COMMODITIES IT INTENDS TO TRANSPORT ARE FURNITURE, AND HOUSEHOLD ITEMS AS A MOVING COMPANY. THE APPLICATION THAT WAS FILED WAS INCORRECT.**
- 4) **APPLICANT WAS DIRECTED TO TERMINATE ANY WEBSITES, FACEBOOK, ETC., NOW THAT ADVERTISES ITS BUSINESS. TO DATE, MORE THAN THIRTY (30) DAYS LATER, THE WEBSITES ARE STILL ACTIVE ON THE INTERNET, AND THE APPLICANT IS STILL HOLDING ITSELF OUT FOR HIRE FOR COMPENSATION IN PA.**

For these reasons, your Application is **DENIED** and **DISMISSED**. Your application fee of one hundred (\$100.00) dollars **will not** be refunded. You must file a new application if you require operating authority.
