Dear Ms. Chiavetta:

I am writing in response to your letter dated October 24, 2022 requesting additional data regarding the above application.¹ Applicant's responses to the inquiries raised in the letter are below:

1. Evidence of Mr. John Tassi, II's qualifying experience: Please see the attached letter from Mr. Tassi's former employer, Lee's Moving & Storage, Inc.
2. Continuous satisfaction of the experience requirement during the initial two-year period of operation: Applicant has executed a two-year employment agreement with Mr. Tassi. Moreover, the agreement provides that Mr. Tassi is required to give thirty days' notice if he intends to resign during the initial two-year period to permit Applicant sufficient time to hire a replacement employee. Applicant understands that it must pause operations if it does not currently employ someone with the requisite experience. That said, Applicant expects that once its authority is granted, it will hire additional employees to meet the needs of its businesses and intends to hire other individuals who have at least two years of experience with a licensed moving company. This way, it will be unlikely that Applicant will find itself without any employee who satisfies the experience requirement.


