In accordance with 52 Pa. Code §§ 54.34 and 62.105, please accept this letter as the notice of Engie Retail, LLC d/b/a Think Energy (“Think Energy”) of recent changes to its ownership structure. Effective November 1, 2022, Energywell Think Holdings, LLC (“Energywell”) has acquired 100% of the limited liability company interests of Think Energy (“the Transaction”). Additionally, in connection with the Transaction, the legal name of Engie Retail, LLC d/b/a Think Energy has been changed to Think Energy, LLC.
