Re: Notice of Assignment of Josco Energy USA, LLC Customer Contracts to Median

Dear Secretary Chiavetta,

Pursuant to the Commission's Interim Guidelines Regarding Notification by an Electric Generation Supplier of Operational Changes Affecting Customer Service and Contracts (Docket No. M-00960890F0013, please accept this joint letter as notice by Josco Energy USA, LLC (Electric Generation Supplier License No. A-2017-2626201) ("Josco"), and Median Energy PA LLC (Electric Generation Supplier License No. A-2017-2631320) ("Median") that Josco will assign its Pennsylvania customer contracts to Median. Median is licensed to serve customers in all of the Electric Distribution Company territories where the assigned customers are located. The undersigned officer of Josco attests that the customer contracts being assigned expressly permit their assignment to another licensed EGS.

The assignment will take effect on or about November 1<sup>st</sup>, 2022, and Median will begin serving Josco's Pennsylvania customers at that time. After the assignment, Josco will have no customers in Pennsylvania. Josco will remain in active operation to serve its load at least until such time as all customers are transitioned to Median, and thereafter will determine whether it will continue to operate in Pennsylvania. As such, this letter should not be considered a notice of cessation pursuant to 52 Pa. Code § 54.41. Any such filing will be separately made by Josco if and when appropriate.

The assignment transaction will be seamless for customers. Median will assume Josco's contracts as they stand. Accordingly, customers will experience no change in terms or conditions for the duration of their contracts. Josco does not apply fees for customers who leave prior to the end of their contract, and Median will honor this provision as well.

As required by the aforementioned *Interim Guidelines*, Josco has sent the enclosed notice to customers to notify them of the upcoming transition of their accounts. Josco and Median's customer service agents have been trained to talk to customers as the transition occurs, and to explain what the transition means for the customers. Josco and Median are confident that this assignment transaction will be seamless for customers.



Both Josco and Median are compliant with their Alternative Energy Portfolio Standards obligations and compliant with all Commission assessments, as confirmed by the attached documentation. Enclosed herewith are **Confidential** copies of Josco's and the Median's Quarterly Reports of Gross Receipts for the last four quarters. Josco and Median respectfully request that these reports be filed under seal, because they contain confidential business and financial information about the company's that could cause competitive harm if publicly disclosed.

Copies of this filing are being served in accordance with that attached Certificate of Service. The companies respectfully request that the Commission note the transaction, and the companies will continue to notify the Commission of any changes. In the meantime, please contact the undersigned with any questions or concerns.

While it has been a privilege to supply your electricity, I am writing to inform you that Josco Energy USA, LLC ("Josco") will no longer be providing your electricity supply service after November 1<sup>st</sup>, 2022. Josco has entered into an agreement with Median Energy PA LLC ("Median") under which Josco's customer contracts will be assigned to the Median.

Median will take over your service contract and will continue to honor Josco's terms and conditions for your electricity supply service. The contracts are assignable by their terms, and the transfer of your service to Median does not require you to do anything – it will take place seamlessly and without any disruption in service. Your utility will continue to read your meter, issue your bill, and respond to emergencies and outages.

Median is an established electricity generation supplier that is licensed by the Pennsylvania Public Utility Commission to provide electricity supply service to Pennsylvania customers. The bill you receive from your Electric Distribution Company will reflect Josco's charges to you up until their last date of service to you, and then will reflect Median's charges to you starting with its first date of service you.
