Request for Information

- 1.) Your financial statement is not dated and does not add up. You must file a new statement of Financial Position, which consists of correct information that is less than 6 months old. This information is to consist solely of assets and debts held by Pittsburgh Moving Pgh LLC.
- 2.) On this application # A-2022-3036597 you listed yourself, Brian Erdman, as the only LLC member of Pittsburgh Moving Pgh LLC. All members must be on file. Is “Alex (Brian)” a member of Pittsburgh Moving Pgh LLC? A managing member of the Company must have the 2-year experience with a licensed household goods carrier. It does not appear that Mr. Erdman has any experience, from the information provided, working for a licensed household goods carrier. Please explain who is “Alex (Brian)” and what is his role in the Company? What are his daily functions and duties? Has “Alex Brian” ever been convicted of a misdemeanor or felony? Will he be serving in a full-time capacity? Will “Alex Brian” be maintaining employment with any other household goods movers, if so, for what Company? Is “Bellhops” a licensed Household Goods carrier? Please provide verifiable evidence that Pittsburgh Moving Pgh LLC can meet the Commission’s requirement for experience as required by 52 Pa. Code § 3.381(c)(1)(iii)(A)(II)(-I-). A simple statement of work history does not provide such proof. W-2. Forms or pay stubs would be verifiable evidence. References in writing may also be supplied. Please provide verifiable documentation of the previous experience.
- 3.) On the dismissed Household Goods carrier application # A-2022-3033044 Amber Hallaman and Matthew Treharn were listed as LLC members. Why are they not listed as LLC members on this application # A-2022-3036597? Please explain the discrepancy.
