This filing is for an **INCREASE** in container and packing labor rates as indicated on 7th Revised Page 36 (applicable on shipments transported 40 miles & less and shipments transported in excess of 40 miles), an **INCREASE** in hourly rates for local moves, the **ADDITION** of notes regarding a handling fee & waiver of minimum hourly charges when move is performed for carrier convenience, and the **ADDITION** of Full-Value Protections charges (this addition is applicable on shipments transported 40 miles & less and shipments transported in excess of 40 miles).

The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are now in compliance.

NOTE 5 - Carrier will supply and charge for supervisor or supervisors as requested by shipper or required by carrier. Hourly rate for each supervisor will be computed from time of arrival of vehicles and men at first point of origin until completion of unloading and dismissal of vehicles and men at final destination unless other time of arrival or dismissal is provided by agreement between shipper and carrier. Supervisor hourly rates will be charged at \$3.00 above additional men hourly rate.

NOTE 6 - Tolls and/or parking permits/tickets incurred by the carrier when transporting the shipment will be the responsibility of the shipper and added to the final charges.

▲ NOTE 7 - HANDLING FEE

Carrier will add a 3% handling fee to the final charges when the customer chooses to pay with a credit card.

▲ NOTE 8 - WAIVER OF MINIMUM CHARGE - CARRIER CONVENIENCE

Carrier will not assess a minimum charge (number of hours) whenever a move requires less than the minimum number of hours filed and said move is performed solely at the carrier's convenience. In such instances, the carrier shall charge based on the actual time required to complete the move plus applicable travel charge.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest, or TruckRouter.

0 - 15 miles	1/2 hour
16 - 30 miles	1 hour
31 - 45 miles	1 1/2 hours
46 - 60 miles	2 hours

For mileage in excess of 60 miles, a travel time charge of 1/2 hour will be assessed for each additional 15 miles.
