1. Based upon the description of your proposed operations it appears that you have applied for the incorrect type of authority. Unless it is your intent to operate on a set route with set pick-up/drop off locations and a set time schedule, then your actual operations fall under the scope of Paratransit authority. Please resubmit the correct application and include a cover letter referencing the docket number provided in this letter and clearly indicate your intent to revise your authority request to PARATRANSIT service.
2. You are required to provide a complete and **dated** balance sheet and the information must be comprised of data which is less than 6 months old. The statement should consist of accurate information and not rounded numbers or estimates. The information provided is also to be strictly limited to assets and debts held by the applicant (BELLO NURSES, LLC), and not the individual member(s). Any property listed must be registered or titled to the corporation – personal property of member(s) should not be included.

Also, ensure that the math works: there are multiple errors in the balance sheet. If you are unsure of how to properly prepare the necessary balance sheet you should consult with an accounting professional PRIOR to resubmitting. Failure to provide an acceptable balance sheet is sufficient grounds for the denial of your application.
