4 THE COURT: All right. Thank you.
5 Good morning, everyone. I'm
6 Administrative Law Judge Darlene Heep. We
7 are here in the matter of Selina Wilson,
8 S-E-L-I-N-A, Wilson versus Philadelphia
9 Gas Works.

10 The docket number is
11 C-20223033472. Is Ms. Wilson present?
12 For the record, this is a telephonic
13 hearing. Is Ms. Wilson present? I'm
14 hearing no response. Is counsel for PGW
15 present?

16 MS. CHRISTLIEB: Yes. Good
17 morning, Your Honor. Graciela Christlieb
18 here for The Philadelphia Gas Works.

19 THE COURT: Good morning,
20 Ms. Christlieb. Do you have witnesses
21 here today?

22 MS. CHRISTLIEB: Yes, Your Honor.
23 I have one witness here ready.

1 THE COURT: The hearing was set
2 for 10:00 a.m. It's 10:05. I would like
3 to allow Ms. Wilson a little extra time to
4 call in. Therefore, we will be in recess
5 until 10:15.

12 returned from a recess in Selina Wilson

7 order, and the hearing notice, stating the
8 time, and that the hearing would begin at
9 10:00. None of the documents that were
10 issued to the complainant were returned as
11 undeliverable.

12 Ms. Christlieb, was anything that
13 you sent to the complainant returned as
14 undeliverable?

15 MS. CHRISTLIEB: No, your Honor.

16 THE COURT: I'll take any motions
17 at this time.

18 MS. CHRISTLIEB: At this time,
19 Your Honor, the Philadelphia Gas Works
20 moves to dismiss this complaint with
21 prejudice for failure to prosecute.

22 THE COURT: I will grant that
23 motion and issue a written decision later
24 in the coming months. Is there anything

1 else that we need to address today?

2 MS. CHRISTLIEB: No. Thank you,
3 Your Honor.

4 THE COURT: Thank you, everyone.
5 And we are adjourned with the court
6 reporter staying on the line, please.
