Please explain which natural gas services you are currently providing, and when you started providing each service within the commonwealth.
2. Reference Application, Section 5.c, Customer/Regulatory/Prosecutory Actions - Applicant’s previously held EGS license at Docket No. A-2010-2157184 was cancelled due to the EGS failing to provide the Commission with the required approved financial security in accordance with 52 Pa. Code §54.42(a). Please provide a detailed explanation of the business controls the company will use to ensure ongoing compliance with 52 Pa. Code §54.42(a).
3. Reference Application, Section 7.b, Financial Fitness – Applicant provided minimal documentation to demonstrate financial fitness. Please provide three recent consecutive months of bank statements.
4. Reference Application, Section 7.f, Taxation – Applicant failed to provide a Revenue ID Number. Please resubmit a complete Tax Certification Statement.
5. Reference Application, Section 8.a, Technical Fitness – Applicant failed to provide a license for each state in which it operates in the electric or natural gas industries. Please provide the missing documentation.
