- 1.) Application A-2022-3033044, indicated the applicant, including all the members, officers, and/or shareholders has not been convicted of a misdemeanor or felony. On application A-2022-3036597 evidence was filed showing the applicant, Brian Erdman, was convicted of a misdemeanor charge. Please explain why the misdemeanor conviction was omitted in the initial application.
- 2.) A data request response on the initial application A-2022-3033044 stated, "Brian Erdman did not work for A & M Friendly Movers LLC". On a data request response on application A-2022-3036597 stated, "Brian was employed by A & M Friendly Movers at our Calabash, NC location from July 2019 through August 2021". Mr. Erdman needs to prove his experience with a licensed Household Goods Carrier, or the equivalent as required by 52 Pa. Code §3.381(c)(1)(iii)(A)(II)(-I-). Provide clear evidence such as pay stubs and/or W-2 forms. This will be needed since Mr. Erdman provided conflicting information on verified statements. Mr. Erdman bears the burden of proving he has the experience to operate safely and legally.
