Please explain how you intend to use the authority for Group and Party 16 or Greater under docket number A-2022-3036855.

Company Response:

MAT Bus Corp. intends to use the authority for Group and Party 16 or Greater under docket number A-2022-3036855 to offer Out-of-District Charter Services for our customers. As a school bus transportation company, we are aware that contracted transportation of school children for school purposes is exempt from requiring a PUC Number. However, MAT Bus Corp. would like the ability to perform trips when both the origin and destination are in Pennsylvania and to receive compensation for said trip outside of our contract with the School District.
