The crocks for 6053, 6055, and 6059 Bunkerhill are located on the property of 6045 Bunkerhill beside their driveway.

Subpoena Duces Tecum: Please bring all documents pertaining to the private vs. public nature of the water line at the end of Bunkerhill, who paid for and repaired past breaks on the water line, when and by whom the water line was replaced, and who is responsible to maintain the water line.

<u>Expected Testimony</u>: He inspected 6059 Bunkerhill on 2/5/18 concerning the party water line break. He can report on whether permits were filed and inspections were done by the Allegheny County Health Department for the work performed at the end of Bunkerhill on the water lines.

<u>Subpoena Duces Tecum</u>: Please bring the permits granted and inspection reports by the Allegheny County Health Department and any other documents pertaining to work performed on the water lines at the end of Bunkerhill Street from the year 1700 until today.

Beverly Services (Plumbing) 3044 Industrial Blvd. Bethal Park, PA 15102 (Expert Witness)

Expected Testimony: They can testify that they tried to repair the water line break under the street at 6041 Bunkerhill on 7/27/20, but that they had to abandon the project due to the deteriorated condition of the water line. They will testify that the repair of the 7 breaks on the main line prior to the break on the party line on 7/27/20 may have hastened the demise of the party line. One, the repairs of the main line caused vibration at the juncture of the main line to the party line. Two, the repairs to the main line required the water in the main to be turned on and off which created pressure surges in the party line.

Michael Facchiano Contracting Steve Anderjack Project Manager 801 McNeilly Road #4 Pgh., PA 15226 (Expert Witness)

Expected Testimony: He can testify that approximately 12 feet of curb was destroyed by their heavy machinery when they dug through the rock garden at 6059 Bunkerhill Street to dig a trench to the old curb stop. He can testify that they dug a 3-foot wide trench in the asphalt road from 6041 Bunkerhill to the curb stop in the rock garden of 6059 Bunkerhill and that this trench is now covered by gravel which is slippery to bikers and pedestrians. He can testify that the street was repaved in front of 6041 Bunkerhill, but not the rest of the street that extends from 6045 to 6055 Bunkerhill. He can testify that that he quoted a price for repaving the street from 6045 to 6055 Bunkerhill to owners of 6053, 6055, and 6059 Bunkerhill before the water line trenches were dug; but after the water line trenches were dug, the price was raised significantly.

<u>Notice</u>: A response or objection to this application for subpoenas shall be filed with the Commission or Administrative Law Judge within 10 days of service of the application.
