CPV Retail Energy LP has been approved for PJM membership (READ ONLY) in the Other Supplier sector and will be announced at the Members Committee ("MC") meeting to be held on 7/27/2022. I have attached original copies of your signed agreements to this email.

Those listed as Authorized Representatives and Maintenance Managers on the designation form submitted with the application have access to the Maintenance feature in the Membership Management Community. An Authorized Representative or Maintenance Manager should login to the tool as soon as possible to designate Company Account Managers (CAMs) and Contact Managers for your company.

Company Account Managers (CAMs): Prior to allowing a Member to utilize PJM tools, the Member must designate CAMs. Individuals designated as CAMs will have full rights to manage individual user accounts on behalf of the company in the Account Manager tool. A minimum of two CAMs must be designated per member company account.

Contact Managers: These individuals will be given access to the Contact Management feature in the Membership Management Community allowing members to manage who is representing their company for various member-level roles at PJM. It is important that those listed as Contact Managers create and assign a Billing Contact, Roster Manager, and other required contacts, for your company as soon as possible. A Contact Management Quick Guide has been attached to provide you with more information.

STANDARD FORM OF AGREEMENT TO BECOME A MEMBER OF THE LLC




Additional Member Agreement


1. This Additional Member Agreement (the 'Supplemental Agreement'), dated as of 7/11/2022, is entered into among CPV Retail Energy LP and the President of the LLC acting on behalf of its Members.
 2. CPV Retail Energy LP has demonstrated that it meets all of the qualifications required of a Member to the Operating Agreement. If expansion of the PJM Region is required to integrate CPV Retail Energy LP's facilities, a copy of Attachment J from the PJM Tariff marked to show changes in the PJM Region boundaries is attached hereto. CPV Retail Energy LP agrees to pay for all required metering, telemetering and hardware and software appropriate for it to become a member.
 3. CPV Retail Energy LP agrees to be bound by and accepts all the terms of the Operating Agreement as of the above date.
 4. CPV Retail Energy LP hereby gives notice that the name and address of its initial representative to the Members Committee under the Operating Agreement shall be:

 6. The Operating Agreement is hereby amended to include CPV Retail Energy LP as a Member of the LLC thereto, effective as of July 11, 2022, the date the President of the LLC countersigned this Agreement.

Application for Membership

PJM Interconnection, L.L.C.

This Application for Membership Agreement ('Agreement') is entered into between PJM Interconnection, L.L.C. ('PJM') and ('Applicant'). The purpose of this Agreement is to apply to become a member of the PJM and to participate under the PJM Amended and Restated Operating Agreement, Third Revised Rates Schedule FERC No. 24 ('Operating Agreement'). The Applicant has read and understands the terms and conditions of the Operating Agreement. The Applicant agrees to accept the concepts and obligations set forth in this Agreement and the Operating Agreement posted on the PJM website at: <http://www.pjm.com/documents/agreements/pjm-agreements.aspx>.

The Applicant also commits to supply data required for coordination of planning and operating, including data for capacity accounting, and agrees to pay all costs and expenses in accordance with the Operating Agreement and all other applicable costs under the PJM Open Access Transmission Tariff ('Tariff'). Such costs include but are not limited to: (i) payment obligations under Schedule 3 of the Operating Agreement; (ii) costs under Schedule 9 of the PJM Tariff; and (iii) potential default allocation payment obligations pursuant to Section 15.2 of the Operating Agreement (PJM may, under the Operating Agreement, declare members in default for not paying their invoices. If that occurs, PJM may pursue collection of the overdue invoices that exceed the collateral PJM holds from the defaulting member as well as take steps to terminate the defaulting members' membership. According to the Operating Agreement, all members are required to pay a portion of the payment default that exceeds the defaulting member's collateral held by PJM.)

The Applicant will pay the annual fee of \$5,000 for the remainder of the year of application upon notification of PJM application approval per Schedule 3.


The Applicant recognizes that it shall become a member of PJM effective as of the date that the Applicant receives the supplement to the Operating Agreement in the form prescribed in Schedule 4 of the Operating Agreement signed by the Applicant and countersigned by the President of PJM pursuant to section 11.6 of the Operating Agreement.

This Agreement will remain in effect until notice of termination is given in writing by the authorized representative of either the Applicant or PJM. Any financial obligations must be satisfied prior to termination of the Applicant's obligations and responsibilities under the PJM Agreement.
