To Whom It May Concern:

In the Order entered October 27, 2022, the Motion for Default Judgment filed by the Commission's Bureau of Investigation and Enforcement on July 29, 2022, was granted. The original Order stated that if the outstanding assessments of \$296 and a civil penalty of \$600 were not paid within thirty (30) days of the entry date of the Order, the Certificate of Public Convenience held by N & W Transportation LLC at Application Docket No. A-2016-2572347 would be cancelled without further action by this Commission.

To date, more than thirty days later, no response has been received from the respondent; therefore, the Certificate of Public Convenience held by N & W Transportation LLC at Application Docket No. A-2016-2572347, has been cancelled

Furthermore, this Commission will the Pennsylvania Department of Transportation to put an administrative hold on Respondent's vehicle registrations. Respondent will **NOT** be able to register any new vehicles or renew any existing vehicle registrations until all past due assessments are paid, all past due fines are paid, all insurance filings are up to date, and it holds an active Certificate of Public Convenience issued by this Commission.

Respondent is hereby notified to cease and desist from further violations of the Public Utility Code, 66 Pa. C.S. §§1.1 et seq., and the regulations of the Commission, 52 Pa. Code §§1.1 et seq. In view of the **cancellation of respondent's Certificate of Public Convenience**, it is specifically prohibited from rendering service as a common carrier by motor vehicle in intrastate commerce in the Commonwealth of Pennsylvania.
