To whom it may concern:

By Secretarial Letter dated November 23, 2022, the Commission dismissed the application of U-Relax Moving Co at Case Docket No. A-2022-3035112, for failure to comply with the filing of evidence of insurance.

Your request for reconsideration has been reviewed and it has been determined that the Secretarial Letter of November 23, 2022 dismissing the application of U-Relax Moving Co, shall be rescinded. It has come to our attention that it was the insurance underwriting department refusing to make filings for the property authority. PA Code regulations needed conveyed to this underwriting team, which caused them to make filings within an extended deadline.

U-Relax Moving Co has now complied with all the requirements. Enclosed, is the certificate of public convenience evidencing the Commission's approval of the following right to operate:

***To transport, as a common carrier, by motor vehicle, property,  
excluding household goods in use, between points in Pennsylvania.***

The number on the certificate of public convenience, which is also the first A# at the top of this page, is the PA P.U.C. No. which should be used for identification markings on the vehicles.

A holder of a certificate of public convenience is advised to become familiar with the requirements of 52 Pa. Code. Failure to comply with all applicable requirements may subject the carrier to penalties, including fines suspension of operating rights or cancellation of authority.

The applicant is hereby advised of its obligation to familiarize itself with the requirements of 52 Pa. Code as applicable to the operation of a common carrier as authorized by this Secretarial Letter. Applicant is further advised that failure to comply with all applicable requirements may subject the carrier to penalties, including fines, suspension of operating rights or cancellation of his authority. You have not previously submitted a copy of a current satisfactory safety rating from the U.S. Department of Transportation or another state with safety regulations comparable to Pennsylvania; therefore, you must demonstrate safety fitness by completing a Safety Fitness Review which will be scheduled by a PUC enforcement officer within 180 days of the date your certificate of public convenience is issued/entered. Failure to submit to the Safety Fitness Review will result in the cancellation of your certificate.
