
OBJECTION TO SUBPOENA APPLICATION FOR DELL AND KATHY ZIEGLER

Complainant has sought a subpoena for two neighbors for one topic, a water break in March, 2017. We are both in our late seventies, for which a trip downtown Pittsburgh in January and expenditure of a day's time, would be a burden and inconvenience. I have offered to put my short testimony in a written statement for submission, but Complainant has refused that offer.
