**EXPEDITED BRIEFING SCHEDULE**

TO ALL PARTIES:

On December 13, 2022, Administrative Law Judge (ALJ) Marta Guhl issued an Order denying the Petition of Grays Ferry Cogeneration Partnership and Vicinity Energy Philadelphia Inc (Grays Ferry/Vicinity) for issuance of an interim emergency order on an expedited basis because Grays Ferry/Vicinity, as the Petitioners, failed to demonstrate that the need for relief is immediate and that the injury would be irreparable if the relief is not granted as required by Section 3.6 of the Commission's Regulations Pursuant to Section 5.305 of the Commission's Regulations, the ALJ certified the matter to the Commission as a material question.


On December 13, 2022, Grays Ferry/Vicinity filed a Petition for Interlocutory Review on an expedited basis and a Brief from the denial by the ALJ. In the filing, Grays Ferry/Vicinity requests that the Commission expedite its review of the matter, specifically, that the Commission address the matter at its December 22, 2022 Public Meeting, or if unable to do so, then alternatively address the matter *via* notational voting no later than December 31, 2022.

Our Regulations, at 52 Pa. Code § 5.305(c), permit a party to submit a brief supporting or opposing a petition for interlocutory review and answer to material question within seven days of service of the petition.

In light of the request to expedite the matter and cognizant of the deadline of the contract involved in this matter, represented as December 31, 2022, we shall modify the time period for filing briefs in support of or opposition to the Petition. **Specifically, briefs must be received by the Secretary's Bureau by 4:30 p.m. on Monday, December 19, 2022.** In addition, courtesy copies of the briefs should be e-mailed, in Microsoft Word (or other compatible format), to the Office of Special Assistants at [RA-OSA@pa.gov](mailto:RA-OSA@pa.gov). Following the submission of any briefs, the remainder of the Petition will be addressed by the Commission in a subsequent Opinion and Order.
