In accordance with 52 Pa. Code § 54.34, governing Electricity Generation Supplier License requirements, EnerConnex, LLC (“EnerConnex”) hereby notifies the Pennsylvania Public Utility Commission (“Commission”) that EnerConnex, a wholly-owned subsidiary of SJI Energy Investments, LLC has purchased the customer book of Curago Energy, LLC on November 15, 2022. Both entities are licensed broker/marketers with the PA PUC.


Applied Energy Partners, LLC is licensed by the PA PUC under Docket #A-2016-2538603.

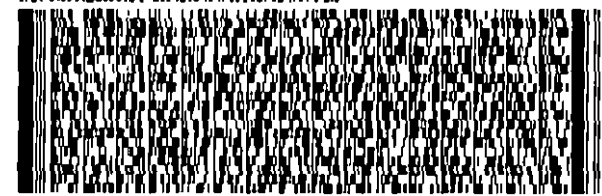

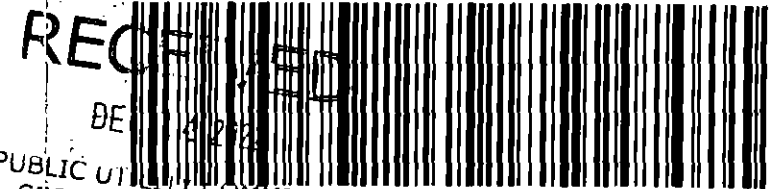
