PUBLIC STATEMENT OF THE OFFICE OF CONSUMER ADVOCATE
PURSUANT TO 71 P.S. SECTION 309-4(e)

Act 161 of the Pennsylvania General Assembly, 71 P.S. Section 309-2, as enacted July 9, 1976, authorizes the Consumer Advocate to represent the interests of consumers before the Pennsylvania Public Utility Commission (Commission). In accordance with Act 161, and for the following reasons, the Consumer Advocate determined to file a Notice of Intervention and participate in proceedings before the Commission involving Tariff Pa. P.U.C. No. 2, Supplement No. 156 of Philadelphia Gas Works, Inc. (PGW), a regulated natural gas distribution utility operating in Pennsylvania.

The Tariff Supplement modifies the date on which PGW Rate GTS-F will terminate, and temporarily extends the termination date pending decision by the Commission in C-2021-3029259, or April 30, 2023, whichever occurs first. The PUC-approved rates and services for customers who were served under GTS-F will be proposed to be made effective for service rendered on and after January 1, 2023.

The Office of Consumer Advocate (OCA) has intervened in the case at Docket No. C-2021-3029259 and is intervening in this case to protect the interests of PGW consumers possibly impacted by this proceeding.
