To Whom it May Concern:


On October 27, 2022, the Commission entered a Tentative Order, Docket No. M-2022-3034805, which advised US Transit Authority LLC that it was not in compliance with the insurance requirements of 66 Pa.C.S. § 512. The Tentative Order advised US Transit Authority LLC, that it must, within 30 days of publication of the Tentative Order, either have acceptable evidence of insurance filed with the Commission or cancel their authority or file comments to the Tentative Order. The Tentative Order advised US Transit Authority LLC, that, if it failed to respond, its certificate of public convenience would be cancelled. The Tentative Order was served on US Transit Authority LLC and published in the *Pennsylvania Bulletin*.

US Transit Authority LLC responded *IN PART* to the October 27, 2022, Tentative Order, but remains in non-compliance with the insurance requirements of the Public Utility Code at 66 Pa.C.S. § 512 for the Group and Party 11-15 Passenger and Group and Party 16 Plus Passenger Authorities.

Furthermore, this Commission will request the Pennsylvania Department of Transportation to put an administrative hold on Respondent's vehicle registrations. Respondent will **NOT** be able to register any new vehicles or renew any existing vehicle registrations until a new application for authority is submitted, in Group and Party 11-15 or Group and Party 16+ vehicle sizes.

**YOU ARE ADVISED:** That the certificates issued at Docket No. A-2015-2464049 and A-2015-2468689 be and are hereby *cancelled*, and all rights, powers, and privileges granted thereby shall forthwith cease and terminate. The Limousine authority at A-2014-2459498 and the Paratransit authority at A-2018-3000529 remain ACTIVE.
