This is not consistent with the Pennsylvania Department of State filing which shows the company's name as "Bright Power, Inc." (notice the punctuation difference). Please either provide a corrected application page or submit a letter stating that the application contains numerous typographical errors and stating the correct name of the applicant consistent with the Pennsylvania Department of State.
- 2. Reference Application, Section 3.a, Affiliates Applicant failed to list its affiliates in this section. Please file an updated application page with the information requested.
- 3. Reference Application, Section 3.b, Predecessors Applicant provided information about its affiliates in this section rather than its predecessors. If applicant does not have predecessors, please write "none" or "not applicable". Please file an updated application page with the information requested.
- 4. Reference Application, Section 11.a, Application Affidavit The Application Affidavit submitted with this application was for the Electric Generation Supplier license. Correct affidavit templates can be found in application package. Please resubmit the Natural Gas Application Affidavit.
- 5. Reference Application, Section 12, Notarized Proofs Applicant provided a notarized proof of publication for the Johnstown Tribune-Democrat in which the ad was missing the applicant's contact information. Please provide a complete notarized proof of publication for the above newspaper.
