ZIPPY SHELL OF PA, LLC
Data Request

1. At present the rights of **Masha Mobile Moving and Storage, LLC, t/a Zippy Shell of Greater Philadelphia** are not able to be transferred due to an outstanding 2022 assessment invoice in the amount of \$1,373. If the balance is satisfied within the next 10 business days the application may continue to process; otherwise, the transfer request will be denied and the filing fee will be non-refundable. If this payment has already been rendered but is not presently credited to the account then please contact the Commission's Fiscal office to have the payment properly applied.
2. Please provide clarification as to who is actually purchasing the rights/ownership of **Masha Mobile Moving and Storage, LLC, t/a Zippy Shell of Greater Philadelphia**. Based on a tentative review of the submitted application it would appear the proper applicant should be **Zippy Shell of PA, LLC**, and not its parent company **Moving Forward, LLC**. The application as submitted is not clear. Please provide a corrected application if appropriate.
3. Is the applicant **Zippy Shell of PA, LLC** seeking to purchase the entirety of the transferor, or only its operating rights? And if **Zippy Shell of PA, LLC** is simply seeking to purchase the transferor's rights, and not to continue operating the transferor, is there a reason that the applicant is not directly applying for its own statewide authority?
4. Be advised that the transferor's Property rights are non-transferable. Should **Zippy Shell of PA, LLC** wish to also provide Property transportation then it will be required to request the authority directly. Correspondingly, if the transferor is ceasing to operate as its own entity then it will be required to separately submit an application to discontinue its existing property rights. This would also be true of the Household Goods rights if **Zippy Shell of PA, LLC** were to directly apply for its own statewide rights and **Masha Mobile Moving and Storage, LLC, t/a Zippy Shell of Greater Philadelphia** was to cease all operations.
