- 1. Reference Application, Section 1.c, Regulatory Contact Applicant failed to provide a Title for the Regulatory Contact. Please provide an updated application page with the appropriate correction.
- 2. Reference Application, Section 1.e, Customer Complaints Contact Info Applicant failed to list their primary and alternate contact's Titles for complaints and customer service. The application requires the full contact information for a primary and an alternate contact. Please provide an updated application page with the appropriate corrections.
- 3. Reference Application, Section 2.b, Business Entity Filings and Registration According to the PA Department of State records, Daniel J Reith LLC was formed in Pennsylvania on 5/1/17 as a domestic limited liability company. These records will need to be updated, since the Applicant was later formed in New Jersey as a limited liability company on 10/24/17. Please provide proof of the updated PA Department of State record that shows that Daniel J Reith LLC is registered as a foreign limited liability company formed in New Jersey on 10/24/17. Additionally, since Daniel J Reith LLC is a foreign (formed in New Jersey) limited liability company, it must update Section 2.b of the Application Package.
- 4. Reference Application, Section 7.b, Financial Fitness Applicant provided minimal documentation to demonstrate financial fitness. Please provide additional financial fitness documentation that includes three recent consecutive months of bank statements.
- 5. Reference Application, Section 8.d, Technical Fitness Applicant failed to provide an Explanation of Ethical Procedures. Please provide the steps Daniel J Reith LLC has put in place that assures its electric generation supplier business will be performed in an ethical manner. Provide an updated application page with the appropriate corrections.
- 6. Reference Opinion and Order at Docket No. A-2019-3008014, Ordering Paragraph #2, Compliance Please provide information to what business controls Daniel J Reith LLC has in place to ensure compliance with the Public Utility Code and the lawful order and regulations of the Commission.
