▲ NOTE 4 - Charges for truck to be based on \$99.00 per day plus \$1.00 per total miles driven based on Google miles. When a 2nd and/or 3rd truck are required, the cost will be \$49.50 per day per truck plus \$1.00 per total miles driven per truck based on Google miles. When Note 6 is applicable, charges shown in Note 4 will not apply. Mover will charge for the driver only at the rate shown for Driver in Columns 2, 3 or 4 above based on the day of the week service is performed.

NOTE AA - A flat charge based on one hour at the applicable transportation rates shown in Columns, 2, 3, and 4 apply if the road miles from the carrier's terminal to both the point of origin and point of destination are 20 miles or less.

NOTE BB - A flat charge based on two hours at the applicable transportation rates shown in Columns 2, 3, and 4 will apply if the road miles from the carrier's terminal to either the point of origin or the point of destination exceeds 20 miles.
