In lieu of the applicable rates provided for in Tariff Freight Pa. P.U.C. No. 50 for the above carrier, the following hourly rates shall apply for shipments traveling between points in Pennsylvania and transported distances of forty (40) miles and less.

Subject to Notes AA, BB, and 1 to 5 below, the transportation charges on any shipment shall be a COMBINATION of the applicable TRAVELING CHARGE named in Column 1 plus HOURLY CHARGE at applicable rates named in Columns 2, 3 and 4.

NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3, and 4).

NOTE 2 - Hourly rates (Columns 2, 3, and 4) are based on the day or days as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in half-hour (30 minutes) increments. Fractions of half-hour to be considered as one half-hour.

▲ NOTE 4 - Charges for truck to be based on \$99.00 per day plus \$1.00 per total miles driven based on Google miles. When a 2nd and/or 3rd truck are required, the cost will be \$49.50 per day per truck plus \$1.00 per total miles driven per truck based on Google miles. When a support vehicle is required to transport team members and/or supplies to and from the job site, cost will be \$1.00 per total miles driven per support vehicle based on Google miles subject to a minimum charge of \$20.00 per support vehicle.

▲ NOTE 5 - Carrier will add a 3% handling fee to the final charges when the customer chooses to pay with a credit card.

NOTE 6 - When BestDarnMovers is renting a vehicle on behalf of client, the client is responsible for the reimbursement of all actual charges assessed by the rental vehicle vendor, including fuel replacement, plus \$1.75 per mile on the mileage rate assessed by the rental vehicle vendor with a minimum reimbursement of actual cost + \$17.50. When Note 6 is applicable, charges shown in Note 4 will not apply. Mover will charge for the driver only at the rate shown for Driver in Columns 2, 3 or 4 above based on the day of the week service is performed.

NOTE AA - A flat charge based on one hour at the applicable transportation rates shown in Columns, 2, 3, and 4 apply if the road miles from the carrier's terminal to both the point of origin and point of destination are 20 miles or less.

NOTE BB - A flat charge based on two hours at the applicable transportation rates shown in Columns 2, 3, and 4 will apply if the road miles from the carrier's terminal to either the point of origin or the point of destination exceeds 20 miles.
