Pennsylvania Corporate Net Income Tax (CNIT) reductions**

Dear Secretary Chiavetta:

Per the Secretarial Letters dated November 9, 2022 and December 15, 2022, UGI Utilities, Inc. – Gas Division (“UGI”) is notifying the Commission that its tax year runs on a fiscal year basis, from October 1 through September 30. Related, the language in Act 53 of 2022 (“Act 53”), (amending the tax reform code of 1971) in paragraph 6.b of section 401 states, “*The annual rate of tax on corporate net income imposed by subsection (a) for taxable years beginning for the calendar year or fiscal year on or after the dates set forth shall be as follows...*”. Accordingly, as a fiscal year tax filer, the initial CNIT rate reduction to 8.99% will be not be effective for UGI until the beginning of the new fiscal year on October 1, 2023. Therefore, UGI will not reflect the initial CNIT reduction in its January 10, 2023 STAS filing but will reflect this initial CNIT rate reduction in its October 2023 STAS filing. Future reductions in the CNIT directed by Act 53 for each year thereafter will be reflected in future STAS filings based on the effective dates for UGI, aligned with the beginning of each fiscal year

Consistent with the Secretarial Letter, the Company has executed a verification affirming the accuracy of the information provided in this letter.




