Pursuant to the Secretarial Letters issued by the Pennsylvania Public Utility Commission on November 9, 2022, and December 15, 2022, Frontier Communications of Breezewood, LLC will not presently be submitting a revision to the State Tax Adjustment Surcharge to account for the recent change in Pennsylvania Corporate Net Income Tax ("CNI"). The Company believes such a filing would be overly administratively burdensome.

Annual waivers have routinely been issued to the Company to reduce the time and costs associated with preparing and submitting two (2) State Tax Adjustment Surcharge ("STAS") filings during the year (April and September). If applicable, the CNI tax reduction will be included in the Company's annual STAS filing in September 2023.
