Ms. Gibbons:

On November 18, 2022, Direct Energy Business Marketing, LLC (Direct Energy Business Marketing) filed a request with the Commission to change the name on its license to provide natural gas services, as a supplier, to Direct Energy Business Marketing, LLC d/b/a NRG Business Marketing.

Currently, Direct Energy Business Marketing is licensed as Direct Energy Business Marketing, LLC as a supplier to residential, small commercial (under 6,000 MCF annually), large commercial (6,000 MCF or more annually), industrial, and governmental customers in the natural gas distribution company service territories of Columbia Gas of Pennsylvania, Inc., National Fuel Gas Distribution Corporation, PECO Energy Company, Peoples Natural Gas Company, LLC – Peoples Natural Gas Division¹, Peoples Natural Gas Company, LLC – Peoples Gas Division, Philadelphia Gas Works, UGI Utilities, Inc., and Valley Energy, within the Commonwealth of Pennsylvania.

Direct Energy Business Marketing has provided the proper Pennsylvania Department of State documentation and has provided proof of service to the interested parties as required by the Commission.

Therefore, the Commission approves, by this Secretarial Letter, the change of Direct Energy Business Marketing, LLC's name on its license for the provision of natural gas services as a supplier.

The Secretary's Bureau will issue a new license to Direct Energy Business Marketing, LLC d/b/a NRG Business Marketing the right to begin to offer, render, furnish, or supply natural gas services as a supplier to residential, small commercial (under 6,000 MCF annually), large commercial (6,000 MCF or more annually), industrial, and governmental customers in the natural gas distribution company service territories of Columbia Gas of Pennsylvania, Inc., National Fuel Gas Distribution Corporation, PECO


