Dear Secretary Chiavetta:

On January 12, 2023, the Commission issued an order at the above referenced docket approving Philadelphia Gas Works' ("PGW") Universal Service and Energy Conservation Plan for 2023-2027 ("USECP") subject to conditions established in the Order ("Order"). In the Order, the Commission directs PGW to file a revised 2023-2027 USECP conforming to the conditions established in the Order within thirty (30) days of the entry date of the Order.<sup>1</sup> The Order includes, inter alia, over thirty changes to PGW's USECP, many of which are substantive.<sup>2</sup> For the reasons discussed below, **PGW respectfully requests an extension of sixty (60) days to submit its Revised 2023-2027 Universal Service and Energy Conservation Plan by April 12, 2023.**

There are numerous conditions, potentially costly system changes, and new policies established in the Order and several of them require significant evaluation for the response. Further, some of the timeframes mandated in the Order may not be feasible; PGW needs time to fully evaluate these requirements before determining how best to proceed. This evaluation and related responsive drafting for the amended USECP will take more than the allotted thirty days.
