THE OFFICE OF SMALL BUSINESS ADVOCATE**

The Small Business Advocate is authorized and directed to represent the interest of small business consumers of utility services in Pennsylvania under the provisions of the Small Business Advocate Act, Act 181 of 1988, 73 P.S. §§ 399.41 - 399.50 (the “Act”). The Act further provides that the Small Business Advocate is to issue publicly a written statement stating concisely the specific interest of small business consumers to be protected by his initiation of or intervention in any proceeding involving those interests before the Public Utility Commission or any other agency or court. This public statement relates to the filing today by the Small Business Advocate of a Notice of Intervention (“NOI”) in the filing of Supplement No. 3 to Tariff Sewer-PA P.U.C. No. 3 (“Supplement No. 3”) by Aqua Pennsylvania Wastewater, Inc. (“Aqua”) that was filed with the Pennsylvania Public Utility Commission (“Commission”) on December 7, 2022.

The Small Business Advocate files this NOI in order to protect the interests of small business customers affected by Supplement No. 3.


The Small Business Advocate will participate in proceedings before the Public Utility Commission to investigate the reasonableness of the proposed special rates for Aqua’s industrial customers as set forth in Supplement No. 3. The Small Business Advocate will ask the Commission to deny any aspect of Supplement No. 3 that is not proven by Aqua to be lawful, just, and reasonable.
