- NOTE 4 MINIMUM TRANSPORTATION CHARGES: Sundays and Holidays (any hour): 8 hours at rates named in Columns 1 and 2. Saturdays (any hour) or Weekdays (5:01PM to 7:59AM): 4 hours at rates named in Columns 1 and 4. Weekdays (8:00AM to 5:00PM): 2 hours at rates in Columns 1 and 3.
- NOTE 5 Carrier will supply and charges for supervisor or supervisors as requested by shipper. A flat charge based on one and one-half (1 1/2) hour at the applicable rates shown in Columns 2, 3 or 4 will be assessed when the distance from original point of origin to final destination is more than 20 miles but not exceeding 40 miles.
