NOTIFICATION TO IDENTIFY STOCKHOLDERS

- 1. Gardner Moving Company is a Pennsylvania business corporation having its principal office at 757 Millers Run Road, McDonald, PA 15057. Gardner Moving Company (hereinafter referred to as GMC) holds operating authority from the Pennsylvania Public Utility Commission at Docket A-00108945 to transport household goods in use between points in Pennsylvania.
- 2. Operating as a partnership consisting of Patricia Irene Gardner and Joseph P. Gardner prior to August 9, 1989, GMC was incorporated in Pennsylvania on July 21, 1989 and common stock was issued as follows:

Joseph P. Gardner, President	50 shares
Michael W. Gardner, Vice President	35 shares
Patricia I. Gardner, Secretary	15 shares

3. From August 9, 1989 to January 1, 2023, shares of stock of GMC have been transferred from and to members of the Gardner family so that the current stock ownership of GMC is as follows:

Joseph P. Gardner	15.5 shares
Michael W. Gardner	14 shares
Michael E. Gardner	30 shares
Mark T. Gardner	30 shares
Alexandra Green	10.5 shares

- 4. There is attached to this notice as Appendix A, a schedule of the various transfers that were made between August 9, 1989 and January 1, 2023. All stock transfers were made in the form of gifts and for no consideration other than for purposes of estate planning. The ownership of the stock of GMC remains in the Gardner family as does the management of GMC.
- 5. No applications for approval of the transfers of stock were made by GMC in connection with the stock gifts and transfers referred to on Appendix A pursuant to 66 Pa. C.S. §1102(a)(3). GMC avers that the intra-family transfers of stock reflected on Appendix A attached hereto, without prior approval, is consistent with the provisions of 52 Pa. Code §69.901(b)(3).
- 6. With reference to Appendix A attached hereto, Joseph P. Gardner, who originally owned 50 shares of the stock of GMC, currently owns 15.5 shares. Michael W. Gardner, who originally owned

35 shares of GMC, currently owns 14 shares. Patricia I. Gardner, who originally owned 15 shares of GMC, is deceased. All of her shares were transferred to family members as reflected on Appendix A. Michael E. Gardner and Mark T. Gardner are the sons of Joseph P. Gardner, and Alexandra Green is the daughter of Michael W. Gardner. The defacto control of GMC, as a result of the stock gifts or transfers, remains in the Gardner family.

WHEREFORE, Gardner Moving Company, by this notice, desires to inform the Pennsylvania Public Utility Commission as to the current stock ownership of this utility.


