On behalf of our client Marathon Power, LLC d/b/a Marathon Energy ("Marathon"), enclosed please find an application for a name change to Energo Power & Gas LLC on Marathon's electric generation supplier (EGS) and natural gas supplier (NGS) licenses. A check in the amount of \$700 for the PAPUC fee is enclosed.

This name change only impacts the company's name and logo. There is no change in ownership, no merger, and no bankruptcy. The new company website is <u>www.energo.com</u>. The email addresses will change to @energo.com. There are no changes to any company addresses and phone numbers. The company's tax identification number and banking remittance information will also remain the same.

On December 12, 2022, Marathon changed its name to Energo Power & Gas LLC in its home jurisdiction of New York (the state in which it is organized) as shown in the attached certificate of status from New York. On December 19, 2022, and January 10, 2023, Marathon electronically filed an amendment to Marathon's foreign registration statement with the Pennsylvania Department of State as shown in the attached receipt. The PA Department of State asproved this filing on January 11, 2023. On January 13, 2023, the PA Department of State also approved the following fictitious names (DBAs): Energo and Marathon Energy.

Marathon also sent the attached customer notice letter to all of its customers in Pennsylvania to inform them of the name change.

Marathon is in the process of updating its name on the company's active financial security (letter of credit from Shell Energy North America) currently on file with the PAPUC and will forward that to the Commission as soon as possible.
