Enclosed for filing on behalf of UGI Utilities, Inc. – Electric Division (“UGI Electric” or the “Company”) are originals of Supplement No. 51 to UGI Electric Service Tariff – Pa. P.U.C. No. 6 and Supplement No. 7 to UGI Electric Generation Supplier Coordination Tariff - Pa. P.U.C. No. 2S, seeking a general rate increase pursuant to 66 Pa. C.S. § 1308 of the Public Utility Code. Also enclosed is an original Statement of Reasons along with the supporting data and testimony, including data required by 52 Pa. Code § 53.52. Electronic copies of all the documents submitted in support of this filing are also being provided by way of a USB flash drive.

In this filing, UGI Electric is proposing to increase its annual jurisdictional revenues by approximately \$11.4 million, or by 7.5% on a total revenue basis. Average customer bill impacts are detailed in the enclosed Statement of Reasons. UGI Electric is proposing that the new distribution rates become effective for service rendered on or after March 28, 2023.


