Telco Pros, Inc. d/b/a TPI Efficiency (“Telco Pros”) hereby applies for an ESG and NSG name change for the above-referenced licenses from the Pennsylvania Public Utility Commission in Docket Nos. **A-2013-2365129** and **A-2016-2531857**. On November 25, 2022, Telco Pros submitted a notice of material change to your attention related to the transaction described below. On December 8, 2022, Jeffrey McCracken from the Pennsylvania PUC advised Telco Pros that the submission should be re-filed as a License Name Change due to the fact that the applicant’s FEIN had not changed. Accordingly, please accept this application in place of the prior notice of material change.

On October 28, 2022, Telco Pros Inc. was converted from an Ohio corporation into an Ohio limited liability company under the name “Telco Pros LLC” within the records of the Ohio Secretary of State in accordance with the requirements of the Ohio Revised Code. Please update your license records for the applicable licenses listed above to reflect this change to the following name: **Telco Pros LLC d/b/a TPI Efficiency**. Telco Pros further discloses that on October 31, 2022, pursuant to a Membership Interest Purchase Agreement, (i) TPI Efficiency Holdings, Inc. acquired the majority of the issued and outstanding equity interests of Telco Pros, (ii) RSZ Enterprise, Inc. retained a portion of the issued and outstanding equity interests of Telco Pros and (iii) the ultimate beneficial owner of RSZ Enterprise, Inc. was granted equity in Telco Pros and became a minority member thereof.

- Telco Pros’ business operations remain the same as before the transaction.
- Telco Pros’ contact/email/website information all remain the same as before the transaction.
- Telco Pros’ FEIN has not changed as a result of this name/structure change. Accordingly, pursuant to the email from Mr. McCracken dated December 8, 2022, since the FEIN remains the same and the name change is minor (changing “Inc.” to “LLC”) customers are not being notified of the name change.





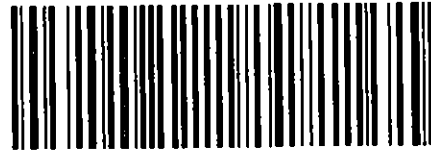

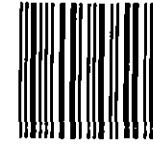
