The purpose of this letter is to request the addition of a new fictitious name to the list of available names for Convenient Ventures, which currently operates under the name, "EnergyObjective". 



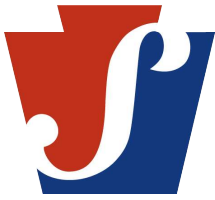
