Dear Secretary Chiavetta:

The purpose of this letter is to request the addition of a new fictitious name to the list of available names for Convenient Ventures, which currently operates under the name, "EnergyObjective". EnergyObjective has been approved for the use of the fictitious name "Shipley Energy Advisors" and desires to commence broker and marketer functions, in both electricity and natural gas, using this fictitious name. Because Convenient Ventures LLC d/b/a EnergyObjective is a broker, its customers' accounts will not be impacted and accordingly submits that no notice to customers is required. Convenient Ventures LLC intends to employ the fictitious name "Shipley Energy Advisors" *in addition to* "EnergyObjective" for the immediate future and may discontinue its use in the future, at which point it would provide notice to the Commission.

None of the information included on the Application for Convenient Ventures LLC has changed, including the contact information. Enclosed is the approved Department of State form DSCB: 54-311 indicating the authorization of Convenient Ventures LLC to use the fictitious name of Shipley Energy Advisors, and payment in the amount of \$350 will be made with the filing as required.

Wherefore Convenient Ventures LLC respectfully requests that the Pennsylvania Public Utility Commission add the additional Fictitious name of "Shipley Energy Advisors" to its Licenses as brokers of electricity and natural gas at the above docket numbers.
