

Contract of Employment



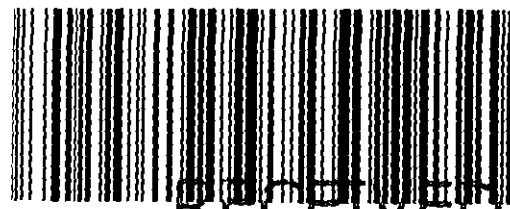
