K-B Offset Printing, Inc. has for fifty years, extensive experience moving and storing materials, paper, supplies, fixtures, equipment, and related materials for it's business operations throughout the Commonwealth of Pennsylvania.

Much of the moving our company property is direct to our end-customer users in the office, factory, warehouse, of homes. The sizes and weights cover a full-range from boxes to pallets, with weights of several pounds to thousands of pounds. Furniture and household goods of any size and configuration fall within the experience and capacity of our company and staff.

Our company has a fleet of five trucks, ranging in size from minivan to 12' & 14' box trucks, cargo van, and a 24' truck. We have considerable materials moving equipment and warehouse experience, forklifts, dollies, hand trucks, trollies, pads, and related moving supplies.

Additionally, in late 2022, K-B purchased the assets of Handy Delivery, Inc., State College, PA (PUC-A107326) including their vehicles, moving aids, and equipment. K-B also hired a few of their select staff with direct experience in the furniture and household goods moving business. A component of the asset sale also included a multi-year consulting agreement with the principals of the former Handy Delivery, who have operated the business for over 40-years.
