The Pennsylvania Public Utility Commission (Commission) writes to inform you that it has accepted for filing Aqua Pennsylvania, Inc.'s (Aqua's) above-captioned application (Application). Specifically, this letter acknowledges Aqua's averment that Aqua and the Pennsylvania Department of Environmental Protection (DEP) were not able to locate a copy of the Ringtown Dam No. 5, Permit No. 54-04 and Aqua's correspondence from DEP confirming the permit's issuance on April 22, 1990. This letter also acknowledges receipt of Aqua's verification that it has provided individualized notice of the Application to all potentially affected Aqua water and Aqua Pennsylvania Wastewater, Inc. customers, and finalizes acceptance of the filing for the Commission's consideration.

The Commission will proceed with publishing notice of the Application in the February 18, 2023, edition of the Pennsylvania Bulletin with a protest deadline of March 6, 2023. If you are dissatisfied with the resolution of this matter, you may, as set forth in 52 Pa. Code § 5.44, file a petition for reconsideration from the actions of staff with the Commission within 20 days of the date this letter is served.
