Dear Judge Guhl:

Philadelphia Gas Works (“PGW” or the “Company”) recently filed notice with the Commission that it intends to file a general rate case in the near future. Regarding the above-referenced proceedings related to PGW’s Weather Normalization Adjustment (“WNA”), PGW will not be filing direct testimony in these dockets at this time.¹ Rather, PGW will include detailed testimony on the WNA as part of its base rate filing, and will also be filing a motion seeking to consolidate the WNA dockets with the rate case.

Additionally, public input hearings have been scheduled in the above-referenced dockets related to the WNA, to be held on March 9, 2023. PGW intends to go forward with these public input hearings and would propose as part of its consolidation request that the transcript of these hearings be considered as part of the record in its base rate filing.

¹ On November 8, 2022, PGW filed a Petition for Leave to Withdraw as well as a Motion to Hold Procedural Schedule in Abeyance in the above-referenced dockets. These requests are currently pending. Additionally, at this time a scheduling order has not been issued setting a litigation schedule in these dockets.
