Request for Information

- 1.) Question #9 of the application asks you to describe the service area proposed by this application. Your answer, “To arrange for the transportation of goods between points in the City of Pittsburgh, Western Pennsylvania, and the Allegheny County area” is not acceptable. The proposed service area needs to have clear and defined boundaries that can be easily identified on a map. Western Pennsylvania and Allegheny County area would be considered ambiguous, and as such, needs to be clearly defined. Please clarify the proposed service area with clear and defined boundaries.
- 2.) In your previous Commission data request, you were asked to remove mention of offering moving services done by the applicant themselves. However, in your response to that data request, once more your Verified Statement of Applicant again refers to operating as a household goods in use service. Please resubmit a new application that reflects that the applicant is applying for a brokerage license to arrange transportation of household goods in use, not to transport household goods in use. If they do not wish to operate as a broker of household good in use, then the applicant needs to withdraw their application of such.
